Details:

- Inspectors continued assisting VTrans at traffic monitoring locations throughout the week.
- 4/14 Inspector assisted Hinesburg Police Department with an inquiry related to the COVID-19 licensing extension.
- 4/15 Inspector assisted DMV Operations deliver a temporary registration and plate to a VT resident who recently lost their job and access to an assigned company vehicle causing an immediate transportation hardship.

Crashes:

- 4/13 Inspector responded to a crash on I91 NB in the vicinity of mile marker 72 for a commercial vehicle that rear-ended a passenger vehicle. A level 2 inspection was conducted. Several violations were found, and a ticket was issued to the commercial vehicle operator.



- **4/17 Inspector responded to VT Rte 25 in Bradford to assist VSP with a two CMV non-reportable crash. The incident occurred on a sharp curve by a bridge. The CMVs, an empty school bus and tractor trailer, side swiped each other in the curve. There was minor damage to both vehicle and no injuries were reported. No inspection was completed.**
