- **No details conducted.**

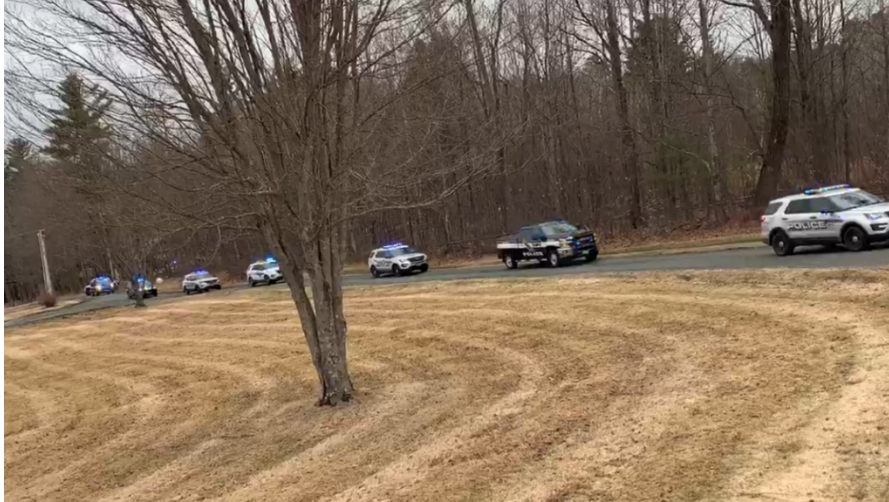
**Crashes:**

A Level 1 inspection was completed with no pre-existing vehicle defects discovered. The CMV was towed from the scene. No injuries were reported.**
