Details:

Crashes:

- 5/6 Inspector conducted a portable weigh and level 1 post-crash inspection in New Haven. A CMV struck a pedestrian on US Rte 7 in New Haven during the night of 5/6. DMV CVE was notified of the crash in the morning of 5/6. The pedestrian died at the scene of the crash. The Vermont State Police are investigating the crash.

Crashes:

Evidence at the scene indicated that the driver may have fallen asleep at the wheel but State Police are continuing their investigation. The driver was transported to the hospital. The truck was totaled.**

- **5/6 Inspector assisted the driver of this tractor trailer after the driveshaft broke free from the truck and damaged the air system while descending Searsburg Mountain. As the driver had no phone service, road service was contacted and the truck was towed.**



- **5/7 Inspector fielded a call from a local Well drilling company regarding expired medical cards. Company was directed to the FMCSA's ruling from 3-24-20 regarding an extension on some expired medical cards**
- **5/8 Inspector responded to VT Rte 11 in Andover to assist a State Game Warden who stopped a tractor trailer after he observed the driver traveling approximately 15-20mph in a 50mph zone and driving left of center. The driver told the Warden he was falling asleep. The Inspector was able to review video of the operation on scene. He completed a level 3 inspection and placed the driver OOS for operating while ill and fatigued. Driver was issued a ticket.**



Safety Audits:
